

- On Oct. 13, 2022 the Board of Trustees installed Fund 40 to deposit \$12 million received from the settlement of the Cunha Water Infiltration lawsuit.
- Why had Fund 40 expenditures not been added to bond presentations for oversight committee review? "Fund 40 is a sort of grey area" Committee requests legal to come instruct and advise on how the now Fund 40 dollars are to be treated.
- Jesus presented to the board the status of bond dollars and Fund 40 at the 2/9/2023 board meeting with an emphasis on conserving as much as possible for the committed projects.
