- Phase 1 includes:
  - Parking Lot and admin building.
  - 5 classes + SPED.
  - o 2 lane drive in loading zone.
  - o Gate entrances at front of school.
- Phase 2 includes:
  - Building B (4 classes)
  - Multi-use room w/2 restrooms
  - Back parking
  - Shade structure
  - PE storage and office space
- Coastal friendly materials will be used, although some steel will be needed to create the aesthetic.
- Project expected to begin next spring/summer. If phase 1 and 2 are done simultaneously, possible completion by 2024

• Phase 3 would include Playgrounds and the modular buildings. The district will need to find financing.
